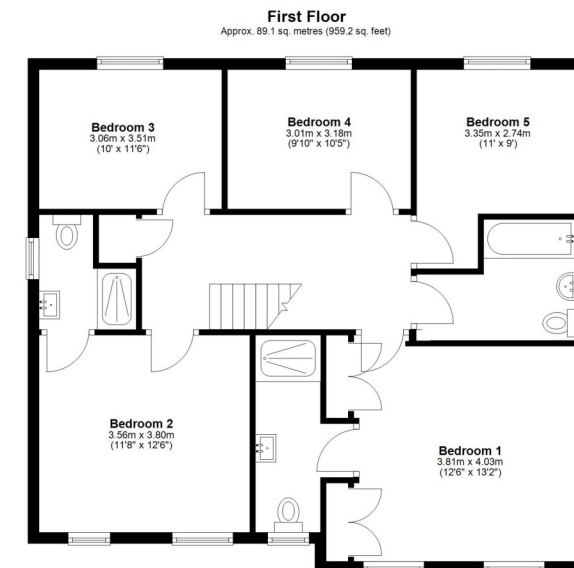
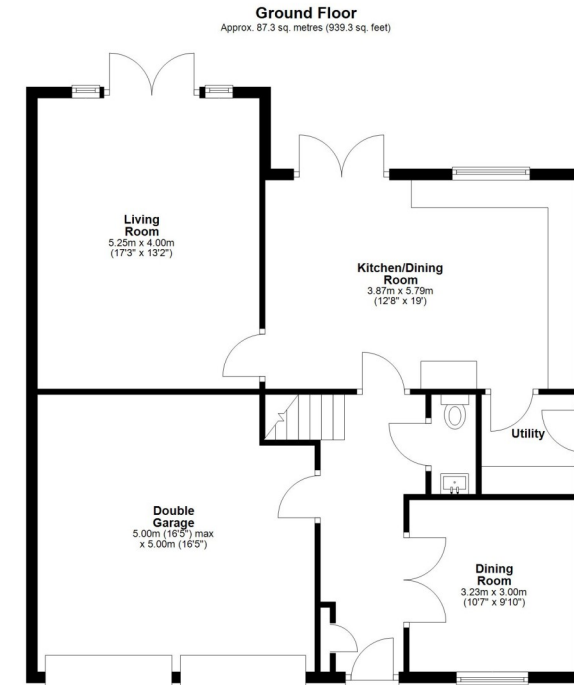

- Convenient for Belvidere secondary school, the excellent amenities of the Abbey Foregate area, good pubs, bypass and M54 and the town centre.

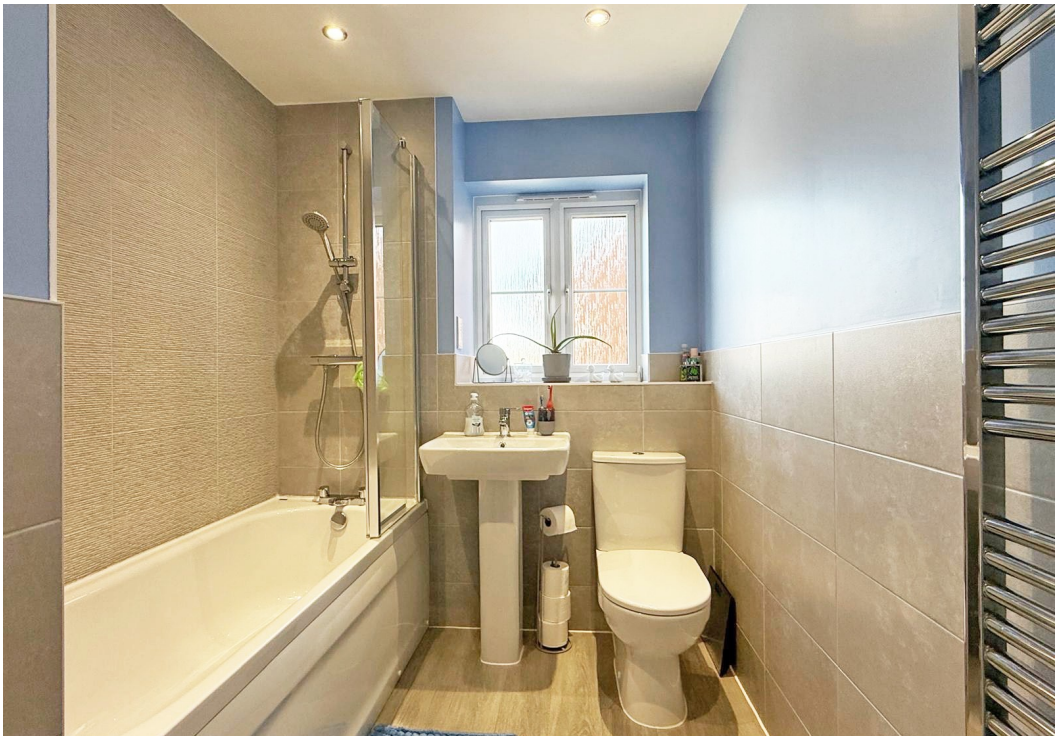

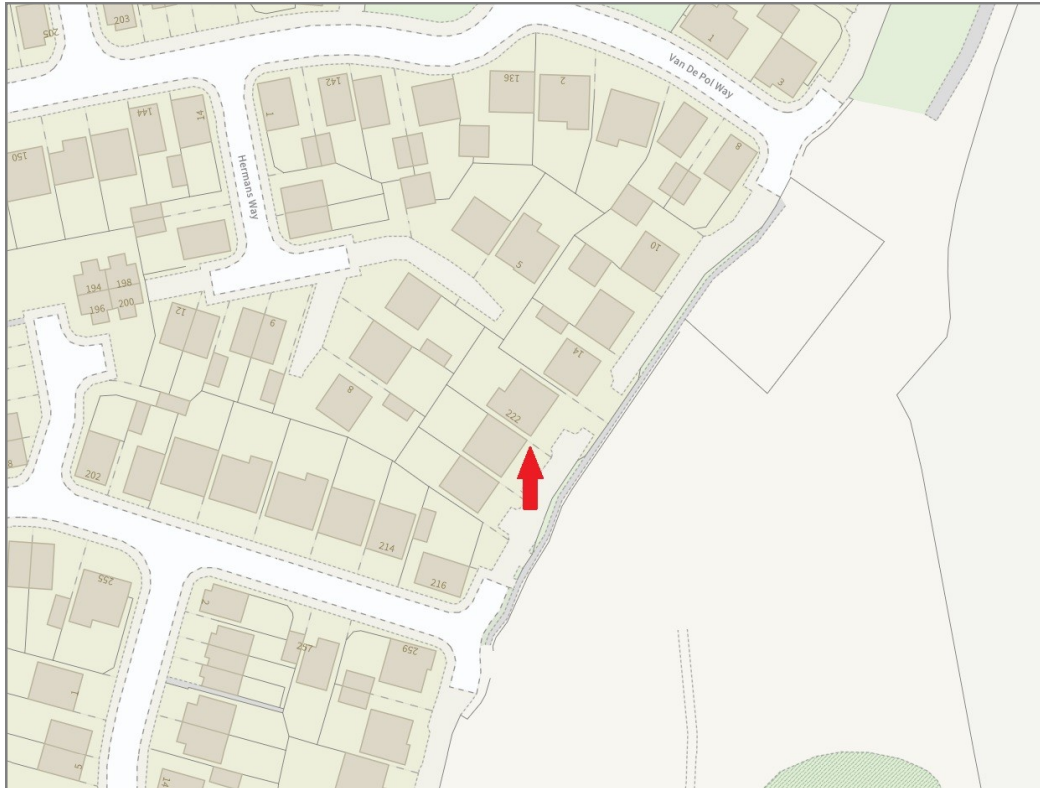

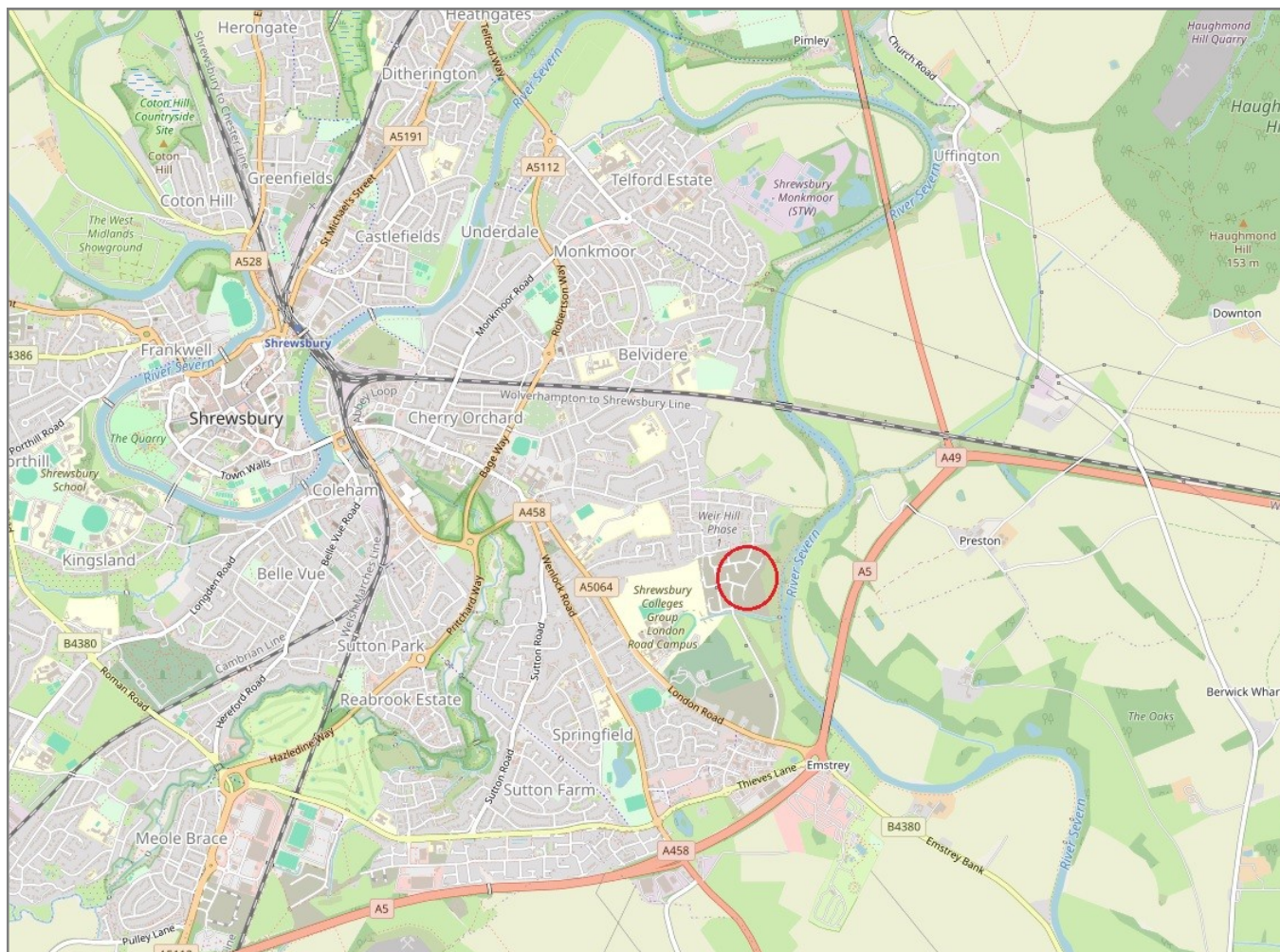
