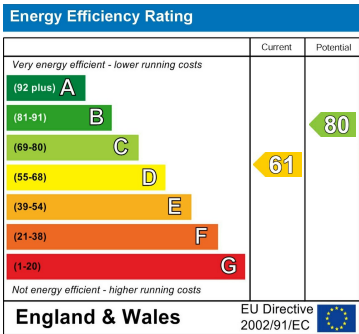
Area Map
