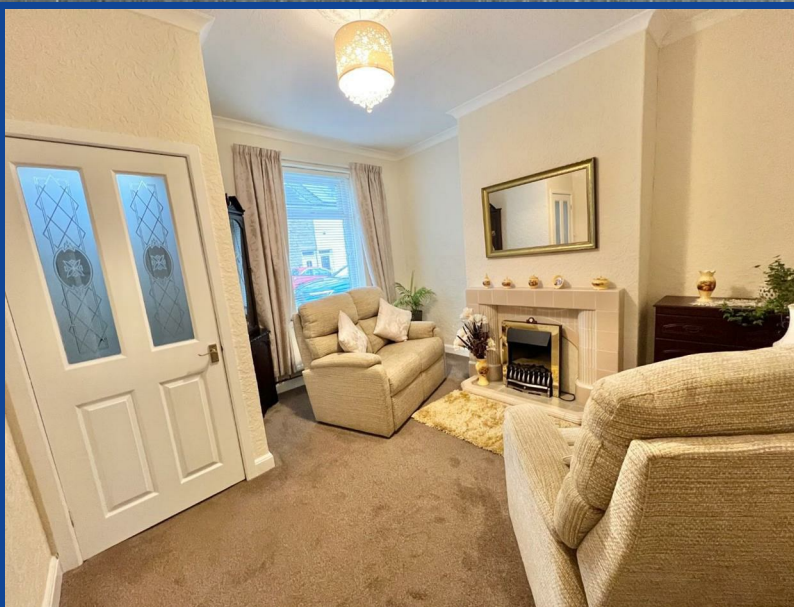

Robinsons are delighted to offer to the sales market, with the benefit of no forward chain, this substantial six-bedroom home. Formerly occupied by a Co-op store, the property was purchased by the current owners approximately 50 years ago and converted into a spacious residential dwelling.

While the house does require renovation to meet modern standards, it offers tremendous potential, boasting six bedrooms, four reception rooms, and a rear yard with multiple outbuildings.

The property is warmed by gas central heating and benefits from double-glazed windows.

The ground floor comprises an entrance vestibule, two reception rooms, a kitchen, and a shower room. A doorway leads through to the area formerly used as the Co-op shop, which includes two generously sized rooms offering excellent scope for redevelopment.

To the first floor, there are six well-proportioned bedrooms. With such extensive space, there is significant potential to reconfigure and create additional bathrooms if desired.

Externally, the property features a rear yard accessed via gates from the front street. The yard includes two sizeable outbuildings with lighting, along with two further storage sheds.

Sunnyside is a pleasant village surrounded by open countryside and is a short drive from Tow Law and Crook, both of which offer a good range of amenities and schooling.

The buyer is required to sign a reservation agreement and make payment of a non-refundable Reservation Fee. This being 4.5% of the purchase price including VAT, subject to a minimum of £6,600.00 including VAT. The Reservation Fee is paid in addition to purchase price and will be considered as part of the chargeable consideration for the property in the calculation for stamp duty liability. Buyers will be required to go through an identification verification process with Iamsold and provide proof of how the purchase would be funded.

This property has a Buyer Information Pack which is a collection of documents in relation to the property. The documents may not tell you everything you need to know about the property, so you are required to complete your own due diligence before bidding. A sample copy of the Reservation Agreement and terms and conditions are also contained within this pack. The buyer will also make payment of £300 including VAT towards the preparation cost of the pack, where it has been provided by Iamsold.

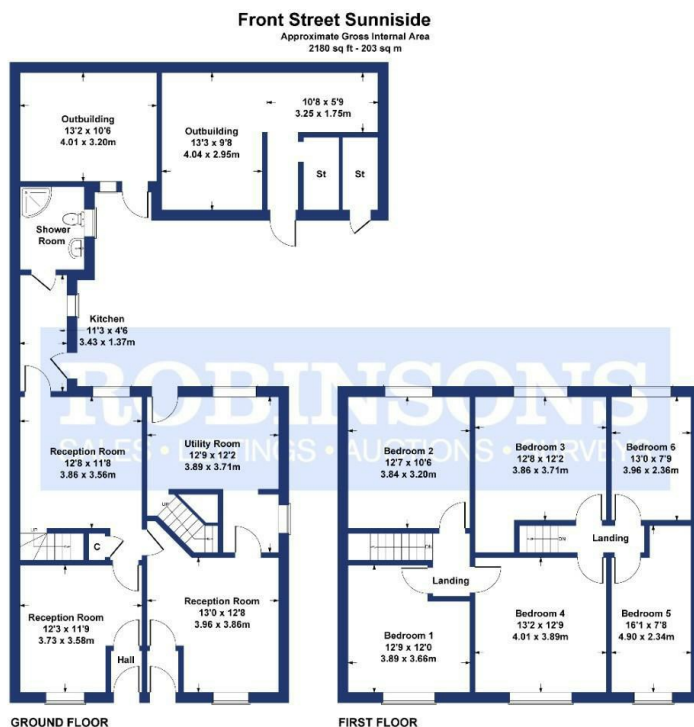
