The accommodation briefly comprises an entrance vestibule leading into the welcoming lounge, featuring a bay window to the front elevation and a log-burning stove. The kitchen is fitted with a range of wall, base and drawer units, incorporating an integrated hob and oven, with space for additional appliances and a dining table. A useful utility room provides further storage and space for a washing machine.

To the first floor are two well-proportioned bedrooms and a family bathroom fitted with a three-piece suite, including a shower over the bath.

Externally, the property enjoys an enclosed rear yard, designed for ease of maintenance and providing an ideal outdoor seating area.

Meadhope Street is perfectly positioned within easy walking distance of Wolsingham's excellent range of local amenities, including independent shops, cafés, restaurants and traditional public houses. The village also offers both primary and secondary schools, regular bus links, and is surrounded by beautiful open countryside, making it an ideal location for those who enjoy scenic walks and outdoor pursuits.
