Arthur Street is conveniently positioned being within walking distance of Crook town centre, schooling and bus links.

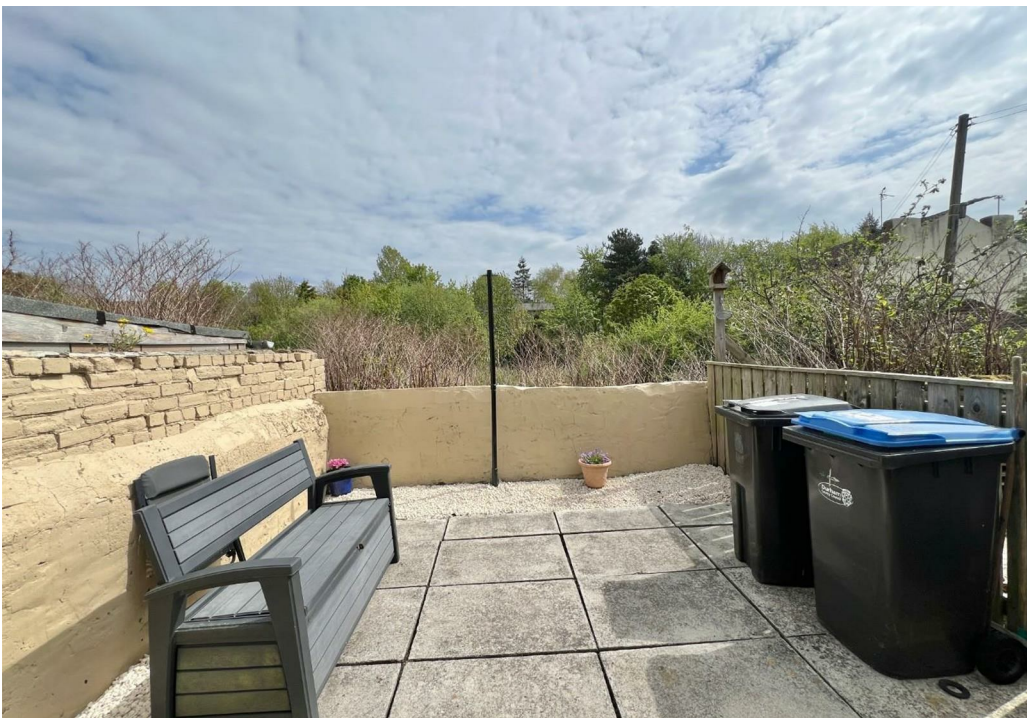

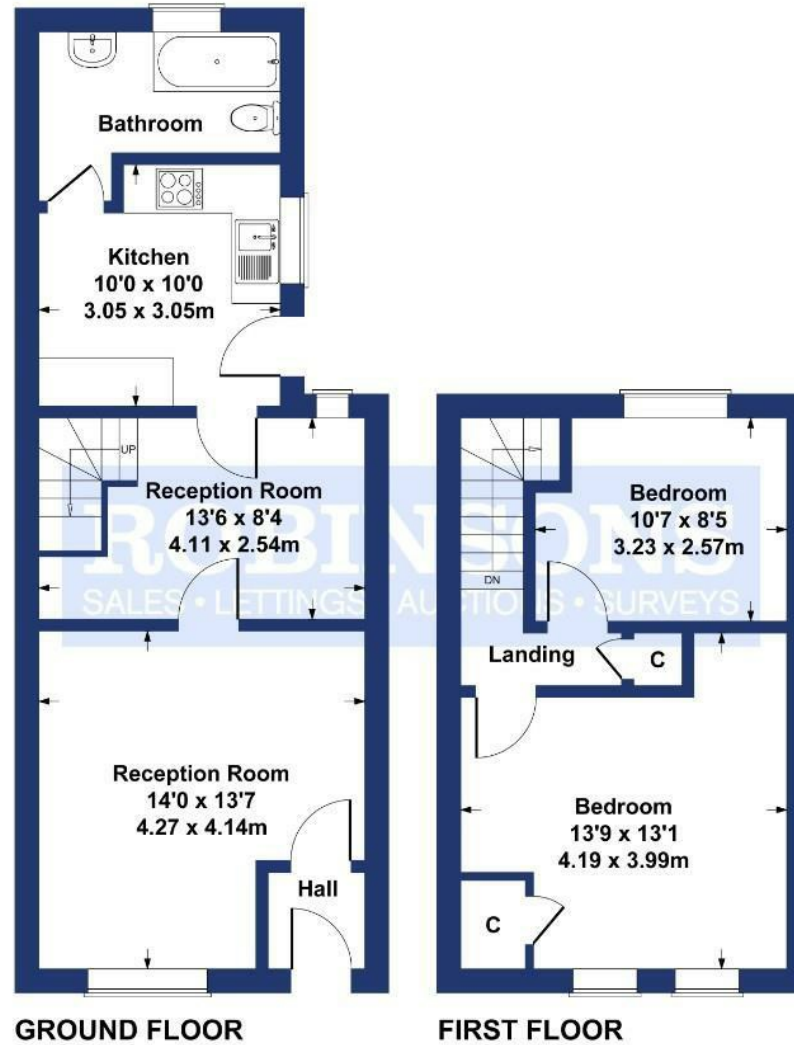
