Jubilee Park is also just a short stroll away, making this an excellent choice for a variety of purchasers, including first-time buyers, young professionals, and growing families.

The accommodation briefly comprises: an entrance hallway, spacious lounge, and a contemporary kitchen and separate dining room, perfect for modern family living and entertaining, the cleverly converted garage to create a four bedroom and completes the ground floor. To the first floor, the landing provides access to three good-sized bedrooms, along with a stylish family bathroom. Externally, the property occupies an attractive plot. To the front, a large driveway provides off-road parking for several vehicles. To the rear, there is a lovely enclosed garden featuring both patio and decked seating areas, creating an ideal outdoor space for relaxing and entertaining and a brilliant summer house which could be used as a home office. 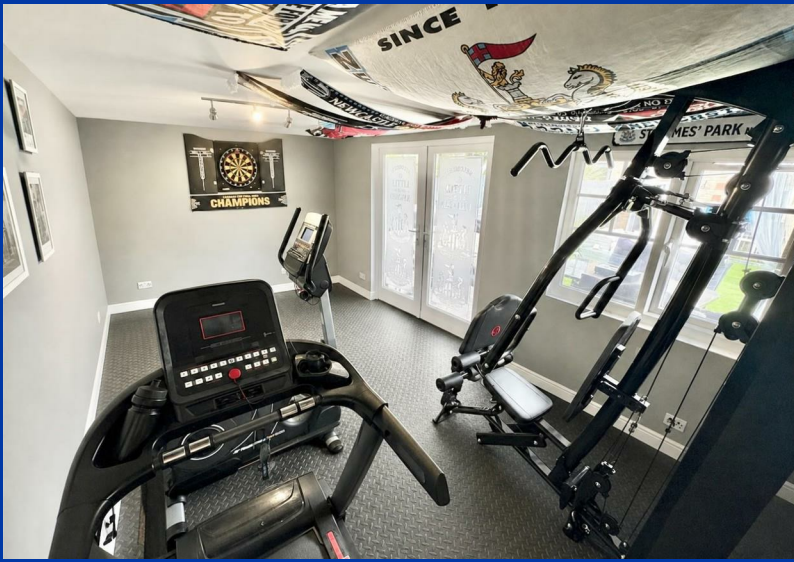
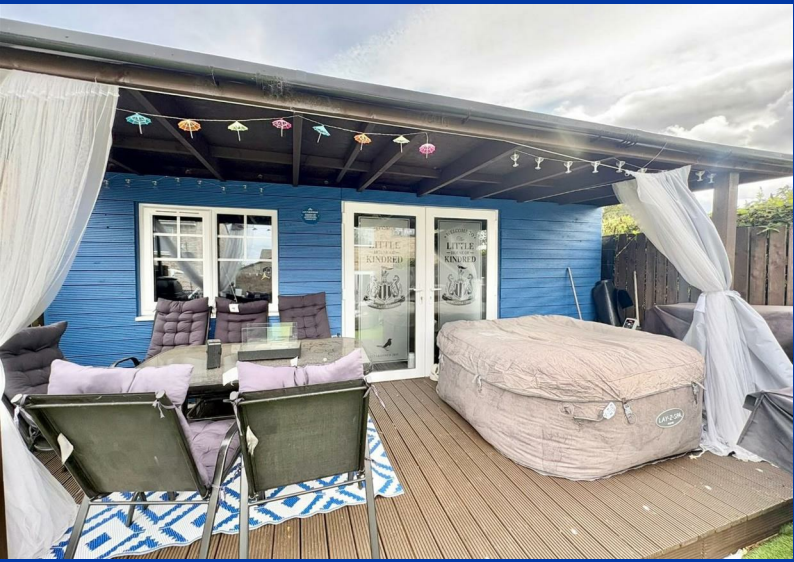

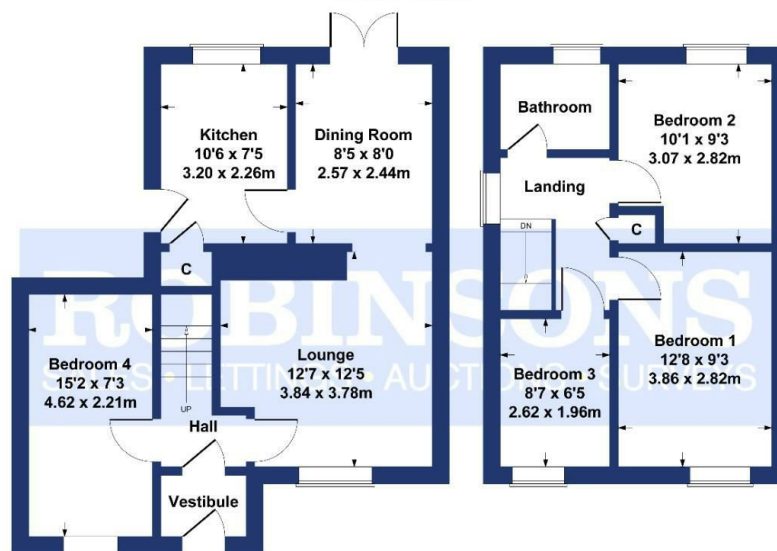
