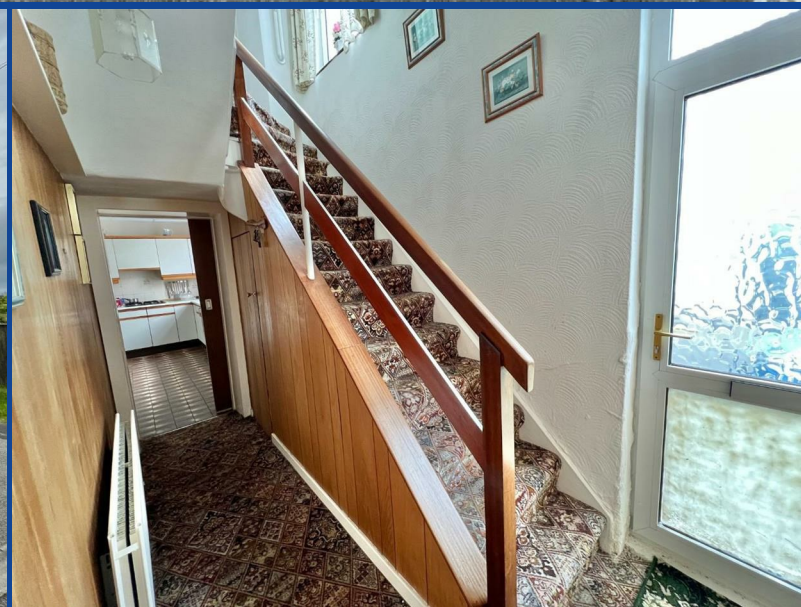

Robinsons are delighted to offer to the sales market, with the added benefit of NO FORWARD CHAIN, this substantial three-bedroom end-terrace property with double garage and gardens, which previously had planning permission (now lapsed) for a detached dormer bungalow. Offering spacious accommodation throughout, the property presents an excellent opportunity to create a superb family home. While requiring renovation and modernisation, the house does benefit from a newly fitted gas combination boiler installed in 2026, complete with a 12-year warranty.

The internal accommodation briefly comprises an entrance hallway with staircase leading to the first-floor landing, a spacious L-shaped reception room with windows to the front and side aspects, and a kitchen fitted with a range of wall, base and drawer units with space for appliances. The kitchen also leads through to a further reception room, ideal for use as a dining room or additional living space.

To the first floor are three well-proportioned bedrooms, along with a study/storage room which provides access to the bathroom, fitted with a four-piece suite.

Externally, there is a rear yard with access to a brick-built storage room housing the boiler. Across the rear lane is a double garage and garden area which previously benefited from planning permission for a detached dwelling. Although the permission has now lapsed, the site may still offer potential for future development, subject to the necessary consents.

The property is well positioned within Shildon, conveniently located close to local amenities, schooling and transport links.

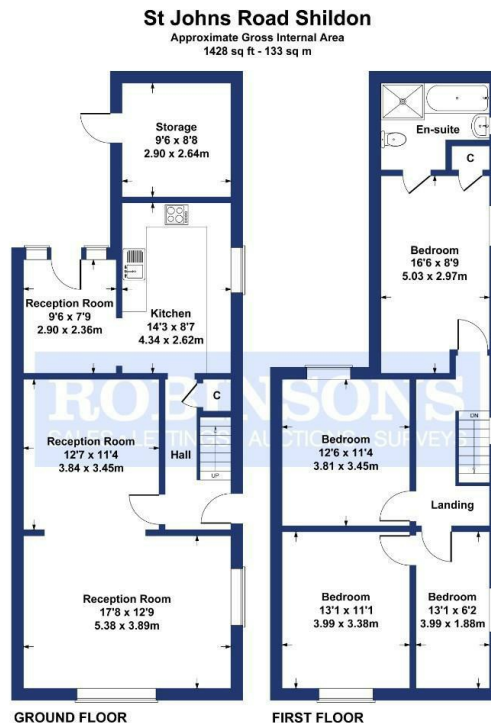
