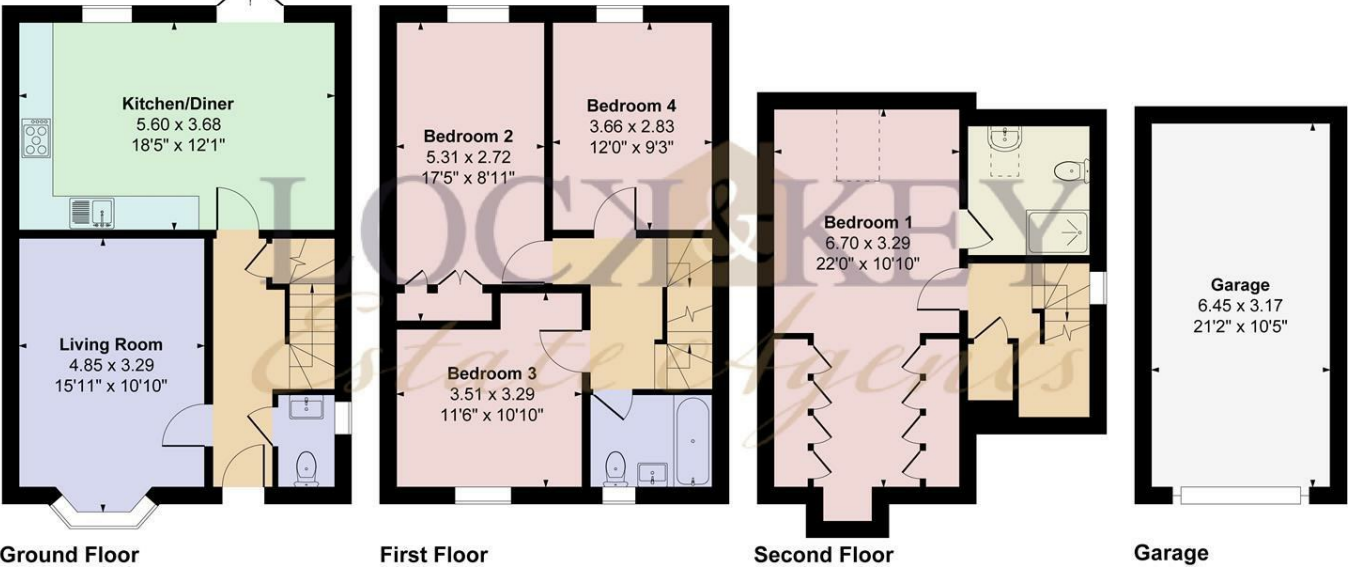
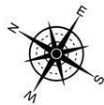
Directions
