LOCATION/SITUATION

Situated in the highly desirable Wychbold/Elmbridge area, the land combines superb access, privacy and rural location. A metal gate provides access via Crown Lane, with good links to Droitwich Spa and surrounding towns.

This is an especially rare opportunity to acquire a functional, level and versatile parcel of land in a sought-after rural location, ideal for equestrian, agricultural, or amenity use.

DESCRIPTION

Extending to approximately 11.14 acres (4.5 hectares), this versatile land offers an outstanding opportunity for equestrian or agricultural use.

The land benefits from roadside access off Crown Lane and has good links to the A38 and beyond.

The land is arranged in two level parcels of Grade 3 pasture, extending to approximately 4.5 acres and 6.64 acres, divided by a well-established hedgerow. The smaller field features a dilapidated barn extending to approximately 100m² providing potential for refurbishment or alternative uses (subject to the planning). Both parcels are enclosed by good stock-proof hedges and fencing, offering secure boundaries and flexible use.

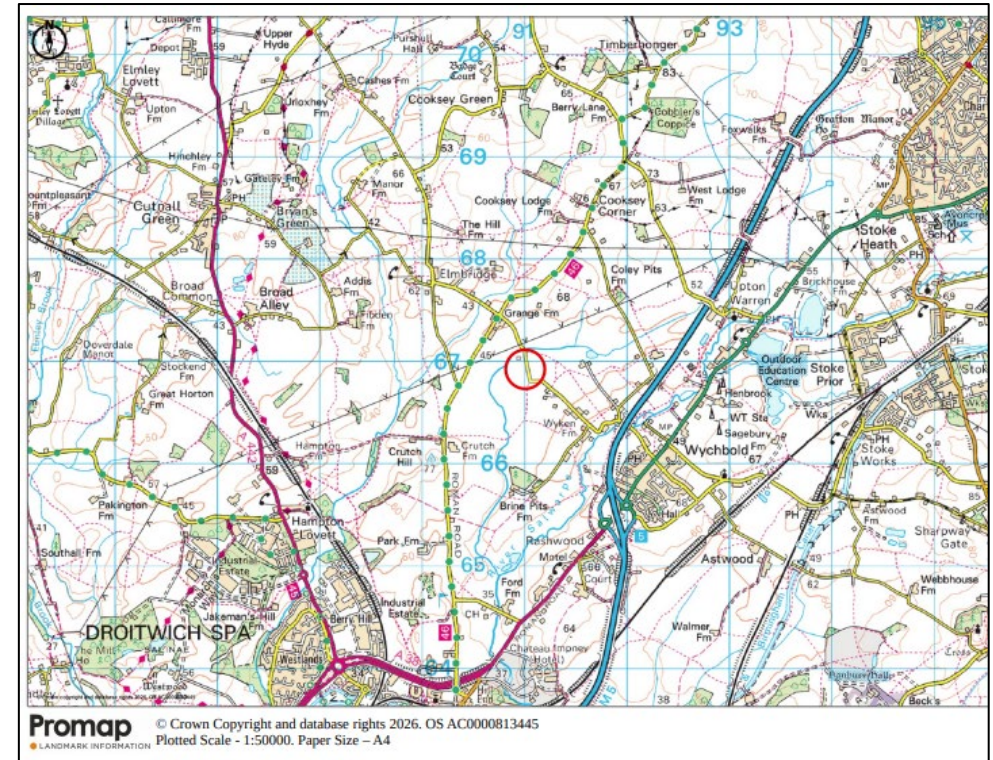
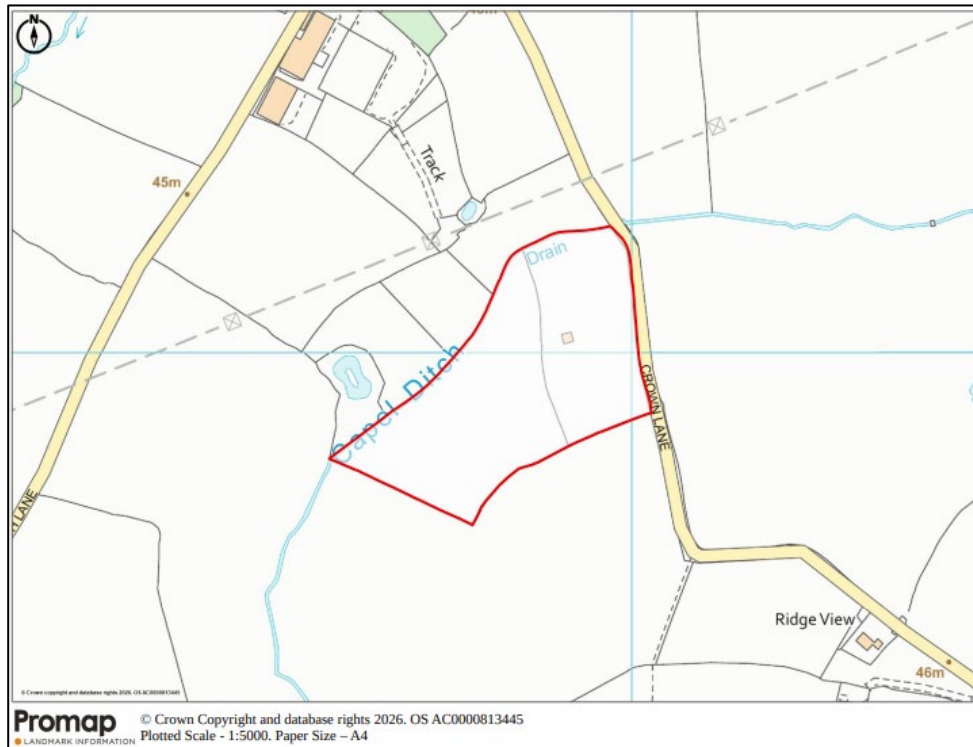
