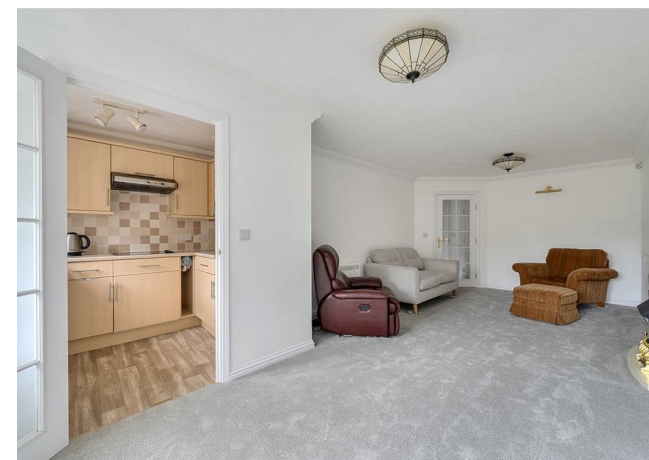
The Lounge offers ample space for living and dining room furniture and has a feature electric fireplace with attractive surround.
