The first floor features a well-designed landing area that provides access to three bedrooms. The upgraded bathroom is both stylish and functional, catering to the needs of a busy family.

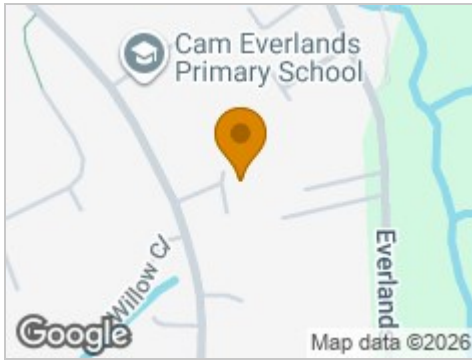

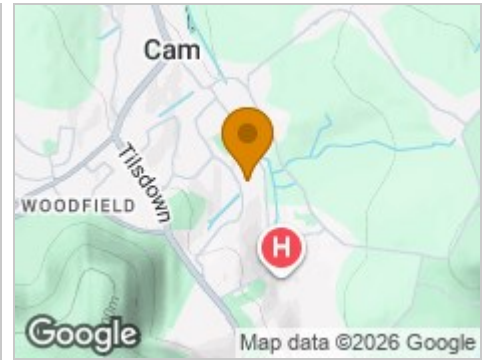
Road Map



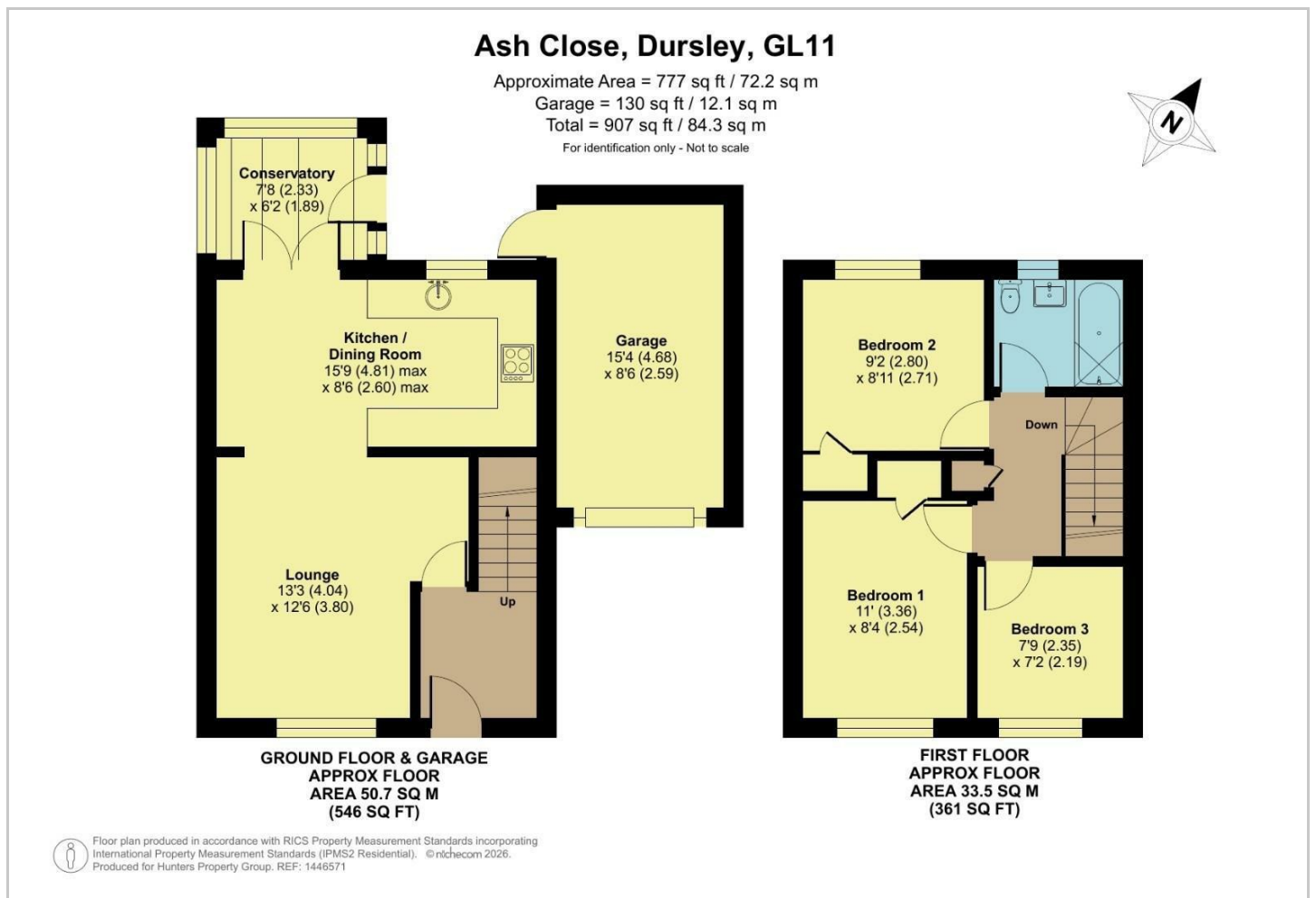
Hybrid Map



Terrain Map



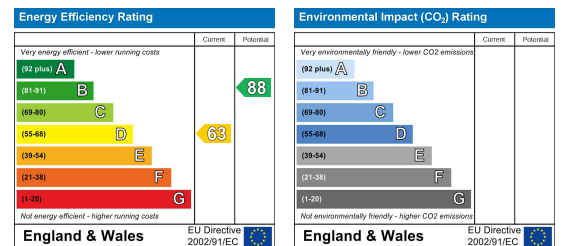
Floor Plan
