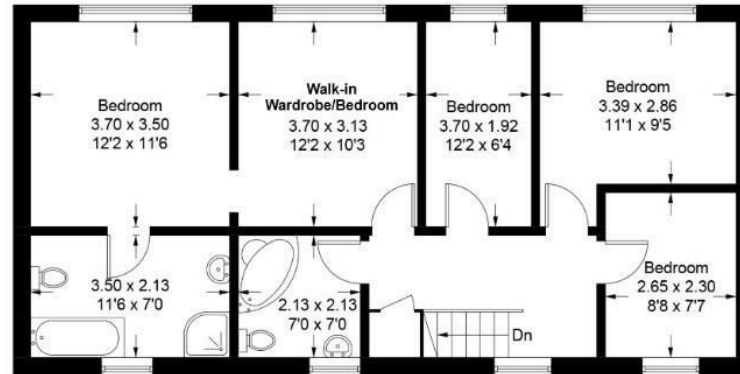

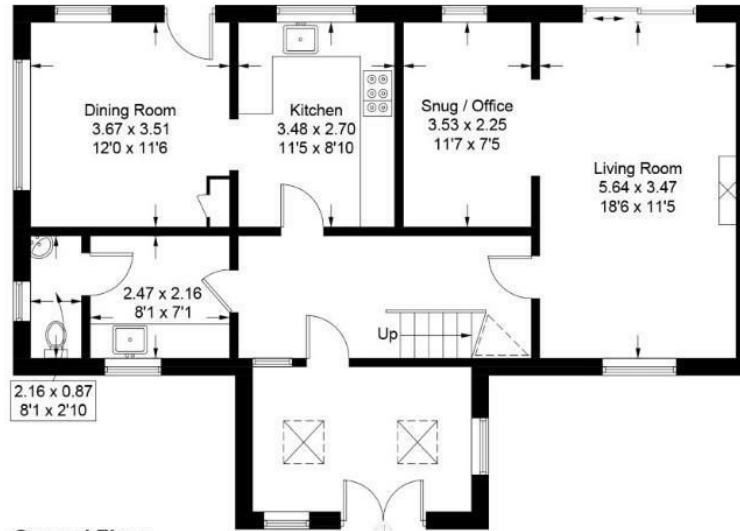

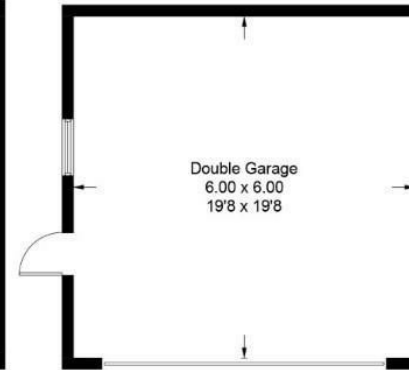


First Floor
