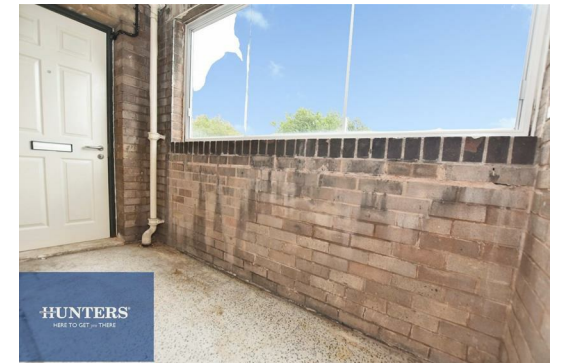

Externally, there are communal garden areas and ample car parking.

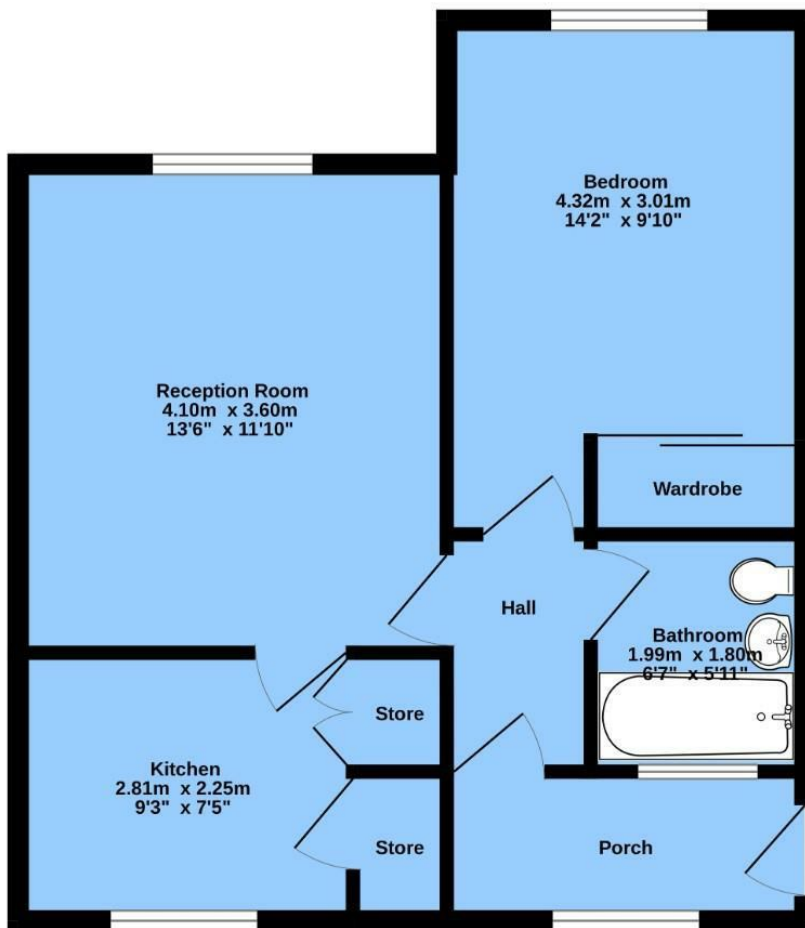
