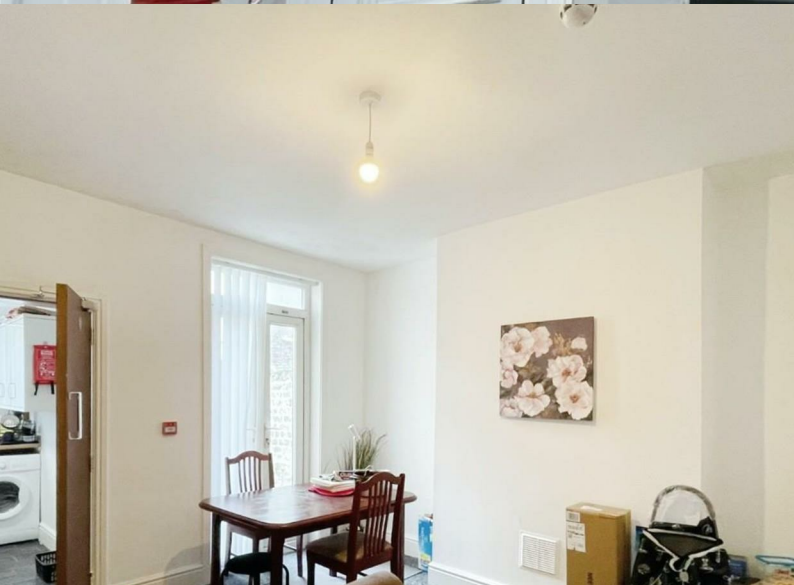

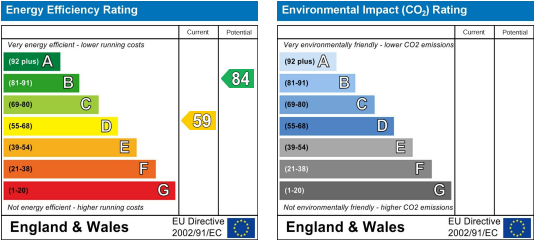
Floor Plan
