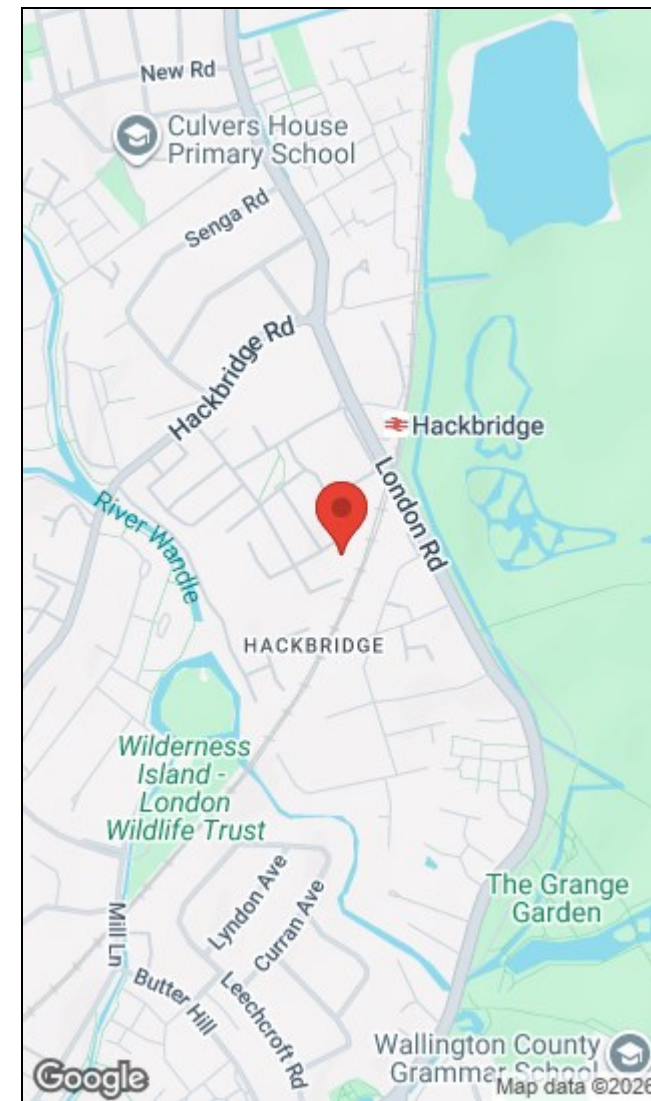


Floor Plan
