Conveniently located for local shops, schools, transport links, and amenities, this property presents a rare opportunity to acquire a home with exceptional potential in a sought-after Wallington location.

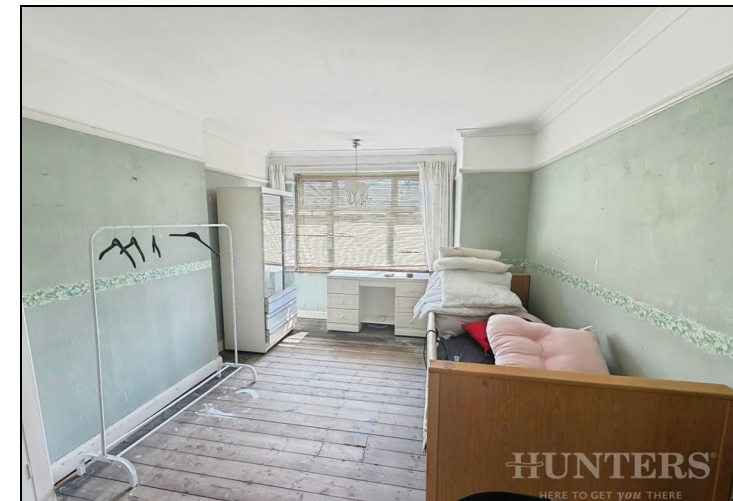
