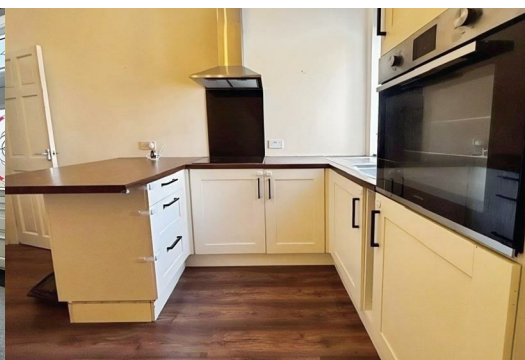

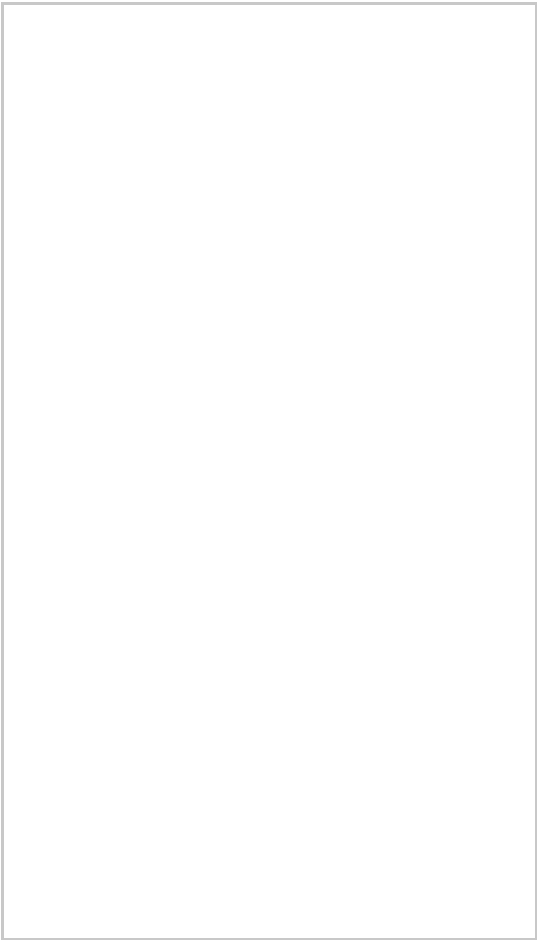

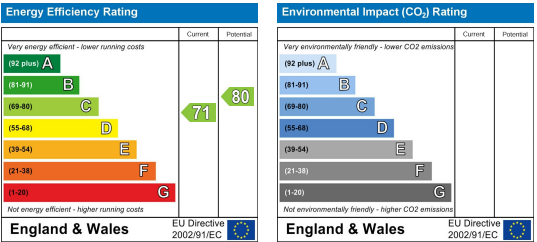
Area Map
