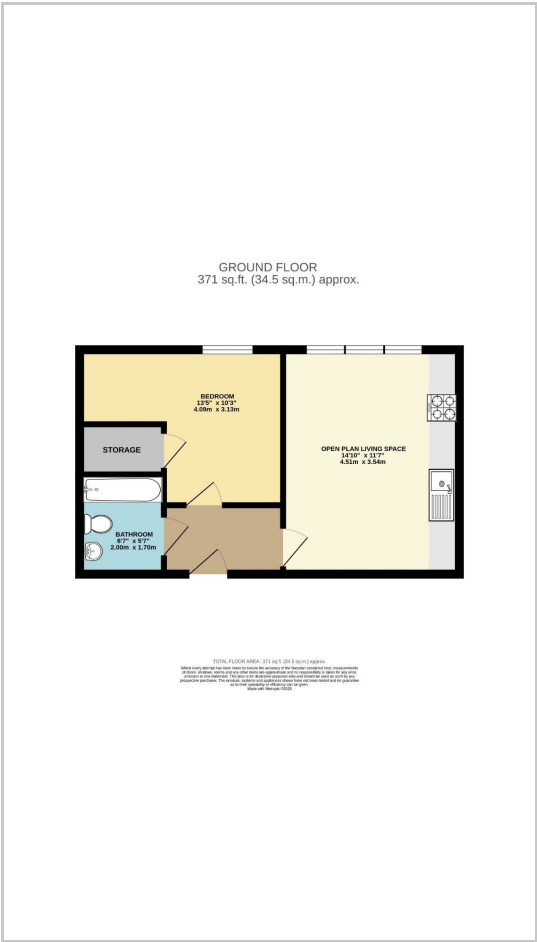
ANTI-MONEY LAUNDERING CHECKS

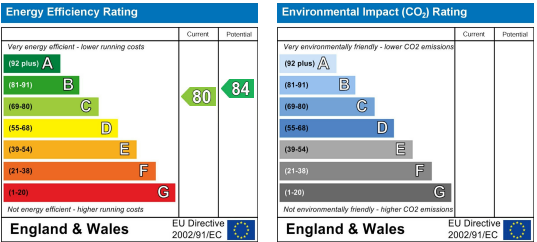
Area Map
