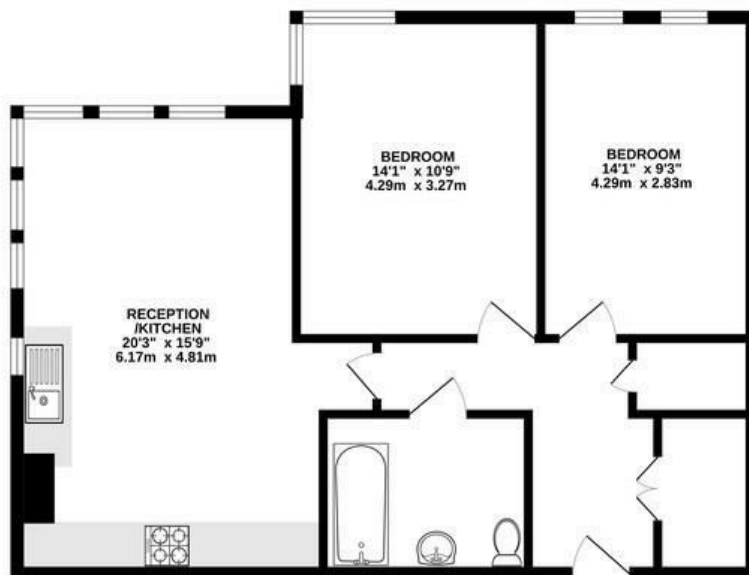
Transport links include Stamford Hill Station (Overground), Seven Sisters Station (Victoria Line & Overground) and a wide variety of bus routes into The City and West End.
