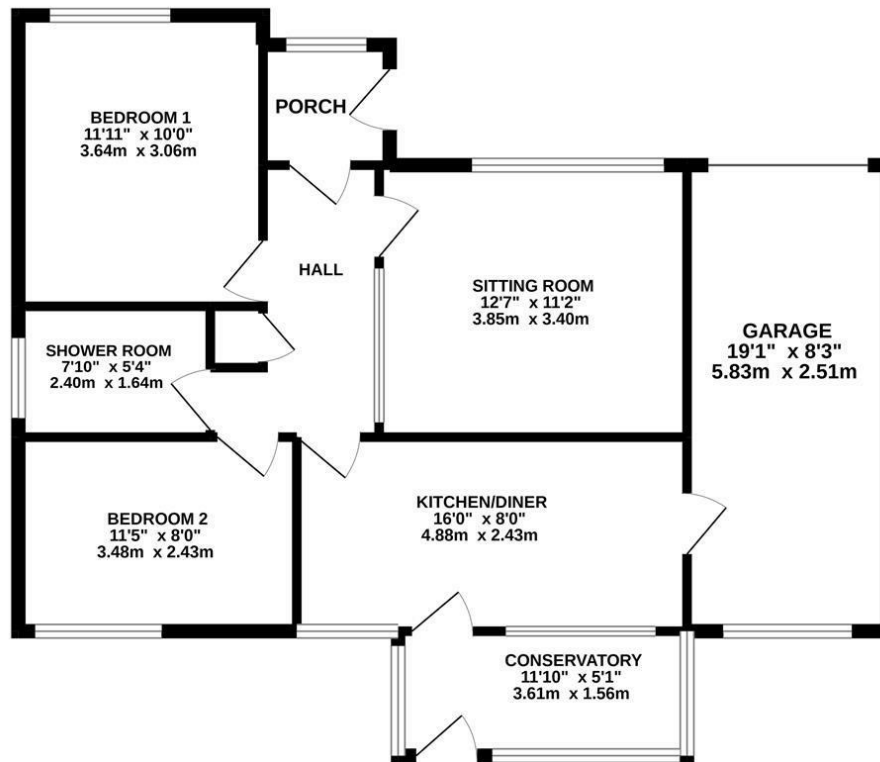
Situated at the end of a quiet cul-de-sac in the popular village of Lymپne. this detached bungalow is double glazed and has gas fired central heating. The accommodation comprises entrance porch through to hallway with doors leading to the lounge, two bedrooms, shower room/wc and kitchen. From the kitchen there is a door to a double glazed lean to and further door from the kitchen through to the garage that houses a Vaillant gas fired boiler and electric roller garage door. There is access to the loft which is insulated and has electric light. To the front is a lawned garden which is wall enclosed and driveway for one car with side access leading to the rear garden which is timber panel fence enclosed and has a timber shed. The property would require some general updating and would suit a variety of buyers. Note the property is being sold as a no chain sale.

The property is close to a good range of local amenities in the village including primary school. Nearby access to Junction 11 of the M20 is a short drive away providing access to the principal towns in the area, also Westernhanger train station is close by which will take you to Ashford International to make the connection to St Pancras, ideal for commuting to London. The Cinque Port Town of Hythe is only a short car ride away and offers a good selection of independent shops together with a Waitrose, Iceland, Aldi and Sainsburys stores. The historic Royal Military Canal runs through the centre of the town offering many walking and recreational facilities as does Hythe's unspoilt promenade. Lymپne primary school is within easy reach, with secondary schooling available in nearby Saltwood and both boys and girls grammar schools in Folkestone.

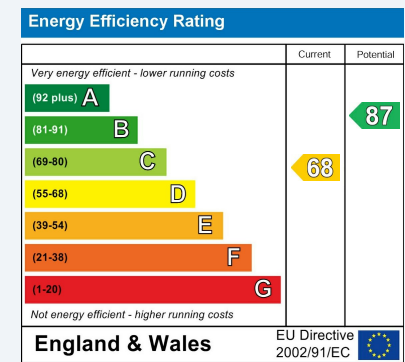
