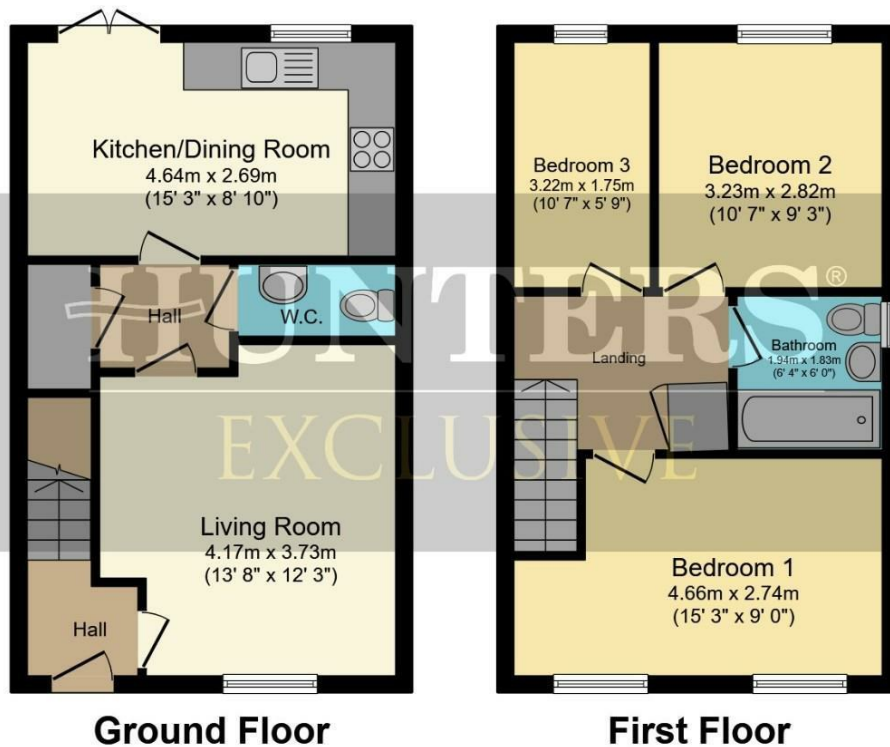
Hybrid Map

Floor Plan



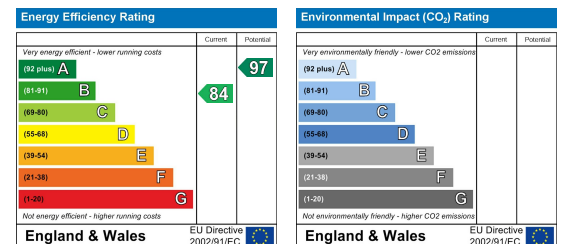
