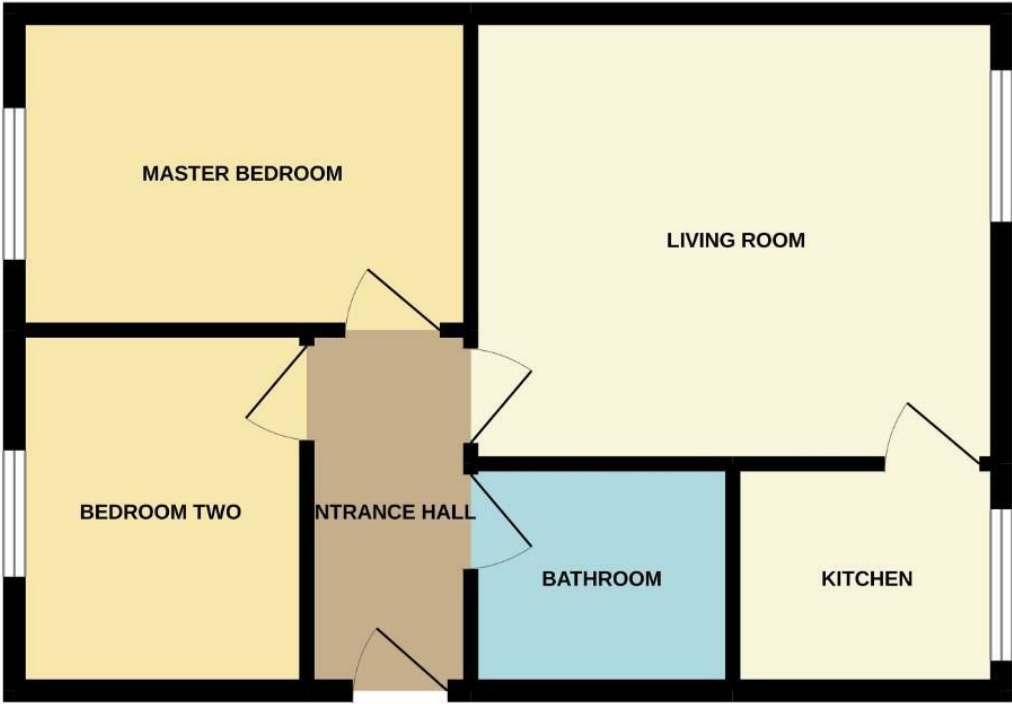

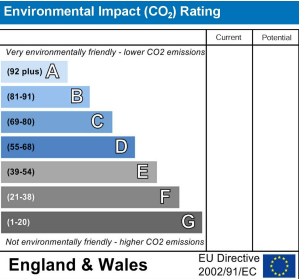
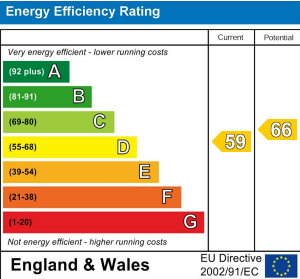

The second bedroom is another spacious double bedroom.

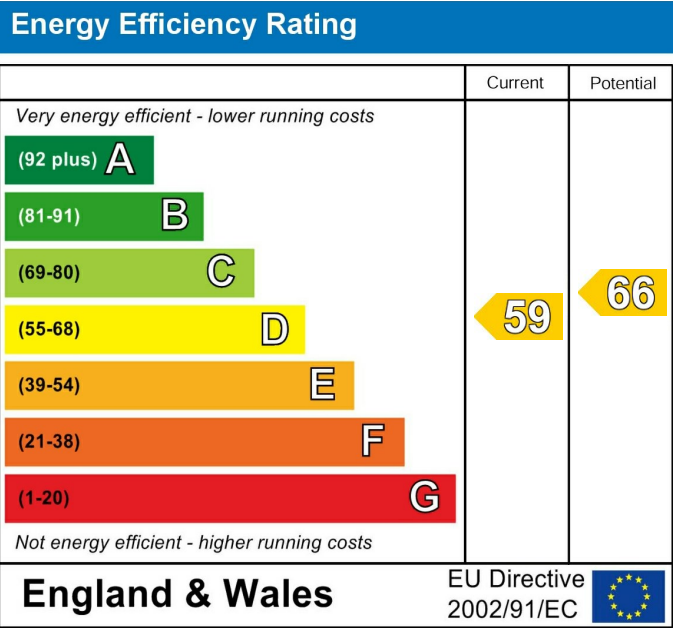
