



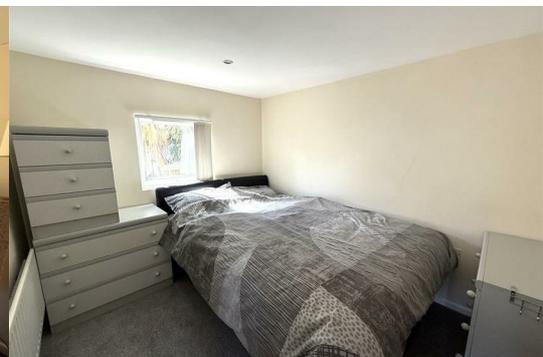

Approached from upvc front entrance door and having inset ceiling lights with window to side aspect. Open plan to Kitchen.

Fitted Kitchen 9'6" x 5'6" (2.90m x 1.68m)

Being fitted with a range of wall and base mounted units with work surfaces over, incorporating inset stainless steel sink with mixer tap, drainer and tiled splash. Gas cooker, fridge and washing machine. Cupboard housing combination boiler, inset lights, radiator and upvc double glazed window to side aspect.

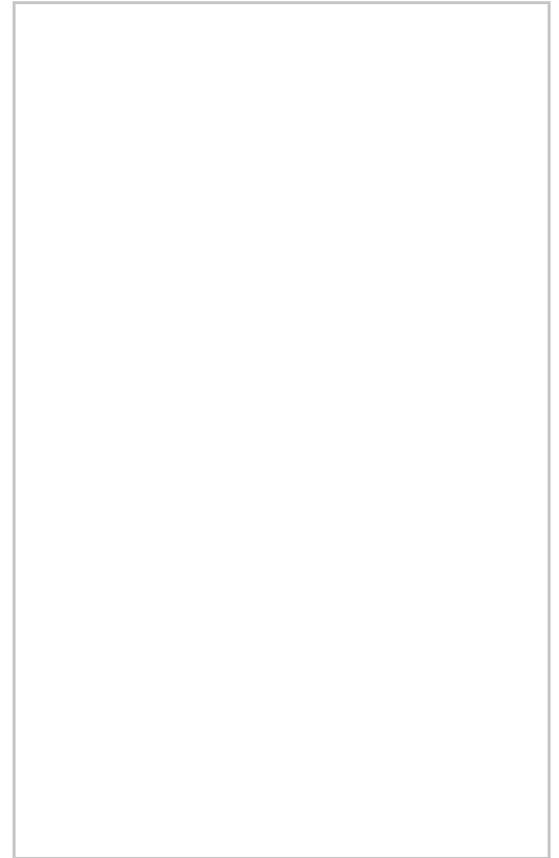
Money Laundering;
