Description:

The sale of this property offers a fantastic opportunity for those with equestrian interests to acquire a block of grassland, bounded by post and rail/wire fencing, totalling approximately 3.23 acres (1.31 ha). The grassland is suitable for both mowing and grazing of all livestock and/or horses, and lays flat. A modern timber-built stable block situates to the northern boundary, upon a concrete base, offering two 12m x 12m loose boxes complete with rubber matting and a useful tack/feed room adjacent. The property benefits from a water and electricity supply, in a pleasant position, with great accessibility into neighbouring towns and villages.

Location:

The property is situated on the edge of the village of Grassmoor, where a range of basic amenities can be found. Further popular nearby towns and villages include; Clay Cross to the southwest (3.4 miles), Chesterfield to the northwest (4.1 miles), and Bolsover to the northeast (6.8 miles). The property boasts close proximity to Grassmoor Country Park and various well-ridden bridlepaths.

Directions:

From the centre of Chesterfield, head southeast on the A617 travelling out of town. Continue along the dual carriageway for approximately 2 miles, before taking the exit for Temple Normanton B6039. Follow the slip road up to the junction, turn right at the crossroads again signposted for Temple Normanton. Continue straight for approx. 0.75 miles before turning right onto Chesterfield Road B6039 and then immediate right onto Birkin Lane. The property can be found approx. 0.5 miles down on the right hand side, indicated by our For Sale board.

Services:

The property benefits from mains water, there is also a spring water supply. The stables benefit from a Callidus solar-powered electricity system, which includes a battery, and a light in each loose box.

Tenure and Possession:

The land is sold freehold, with vacant possession upon completion.

Mineral, Sporting and Timber Rights:

Included as far as they exist.

Viewing:

The property may be viewed at any reasonable time when in possession of a copy of these particulars. Please park carefully and considerately.

Rights of Way, Wayleaves and Easements:

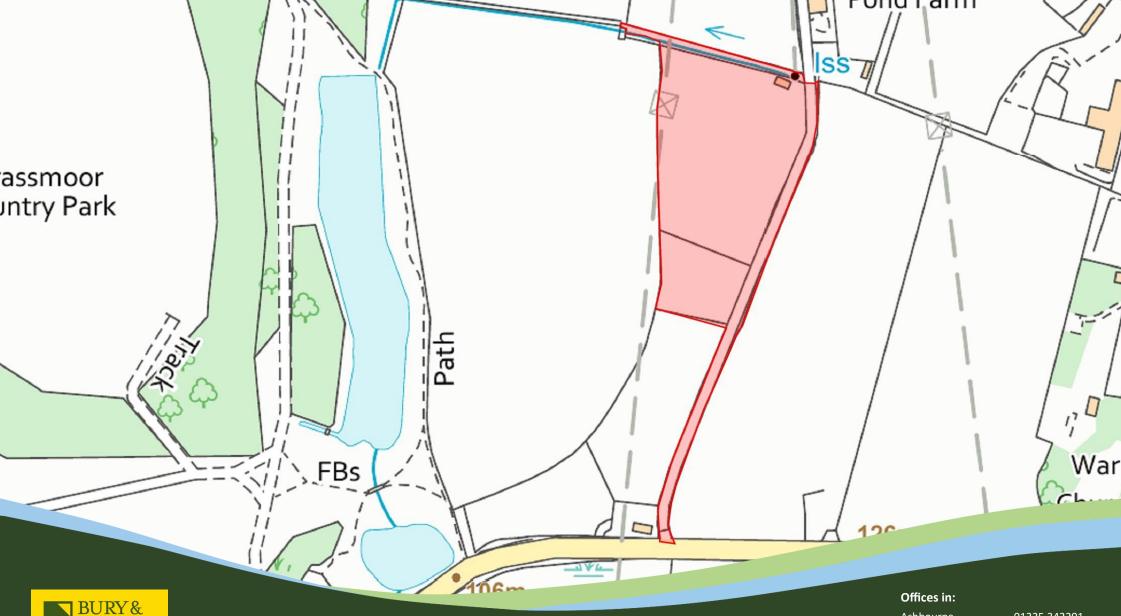
