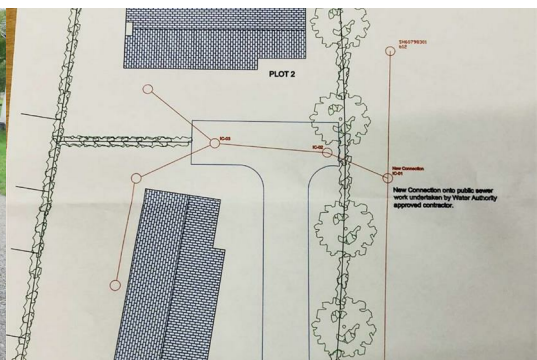

Planning permission has been granted (Application 35C328B) for the erection of two detached bungalows originally approved in 2017, with a variation given to allow an extension of submission of reserved matters to 10th March, 2025.

The planning permission is given with the option for to the developer to sign a Section 106 Agreement removing the need for Affordable Housing, subject to a payment to The Isle of Anglesey County Council, a sum of £102,666. Full details available on request.

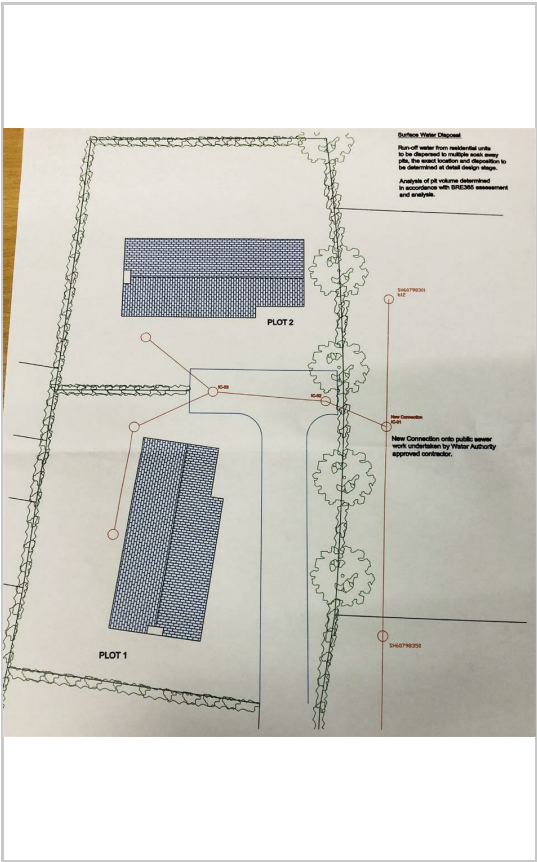
Special Conditions

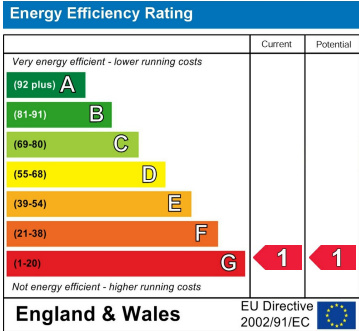
Area Map
