LOCATION

Situated in the village of Heversham, a short distance from Milnthorpe.

ACCOMMODATION

Available unfurnished, the property comprises of three double bedrooms, bathroom with separate bath and shower, lounge, kitchen, dining room and large sun lounge.

GENERAL INFORMATION

Income requirement for this property is £30,000.

TO APPLY FOR A TENANCY

If you wish to apply for a property through Mint Homes after a viewing, you need to apply for it directly from our website. Once approved, we will require a Holding Deposit of 1 weeks rent (calculated by annual rent/52), payable by bank transfer. RIGHT TO RENT

All adults, 18 years and over, living at the property will be asked to provide evidence of nationality and identity to validate their "Right to Rent" under the Immigration Act 2014.

REFERENCING

All applicants will be required to provide satisfactory references from an employer and current landlord. If you are self-employed, a reference from your accountant will be required. A credit reference will also be obtained for each applicant.

THE TENANCY

The property will be let on an Assured Shorthold Tenancy for a minimum period of 6 months.

DEPOSIT AND RENT

The successful tenant will be required to pay a deposit equal to 5 weeks rent following confirmation of references. This will be held in accordance with the Tenancy Deposit Scheme Regulations. One month's rent in advance is required prior to check in

- Cash Deposit - A maximum of 5 weeks rent is required which will be registered with the DPS.
