Number three is a spacious detached family villa which is situated at the end of a quiet cul de sac location within walking distance to the town's amenities.

The property is entered from the front into the glazed, entrance vestibule where a further door leads into the hallway.

The bright lounge offers a picture window to the front and double doors lead into the dining room with a window to the rear. Doors from the dining room and hallway give access to the kitchen area which is fitted with wood effect base and wall units, stainless steel sink and drainer. Electric oven and hob with extractor above. Integral dishwasher and fridge. Separate utility area with base units, space for fridge freezer, washing machine and tumble dryer. A door leads to and windows overlook the garden to the rear.

Within the hallway there is a storage cupboard and W.C. fitted with wash hand basin, W.C. and opaque window.

A staircase leads to the upper level with window. The master bedroom offers a window to the rear, fitted wardrobe facilities and fitted bedside cabinets. The en suite wet room can be accessed

via the master bedroom or hallway and is fitted with a W.C., wash hand basin, shower area with mixer shower. Opaque window.

Bedroom 2 offers a window to the front and fitted wardrobe facilities,

Bedroom 3 offers a window to the front and storage cupboard.

The property offers gas central heating and all windows are double glazed.

A driveway to the front offers parking for up to three vehicles and leads to the detached garage which is accessed via an up and over door to the front and courtesy door to the side.

The garden to the front is laid to lawn with mature trees, shrubs and bushes.

A gate leads to the enclosed rear garden which is mainly laid to lawn.

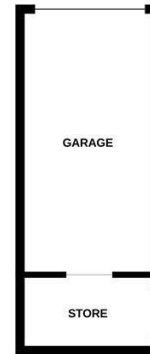
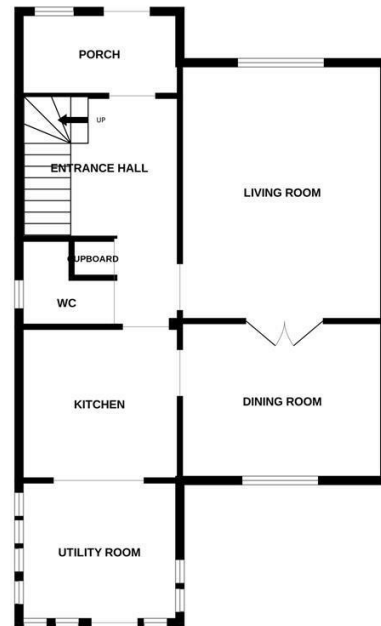
