Positioned in a bustling area with high footfall, the property is just a short distance from the town centre and benefits from its proximity to local schools, shops, and Lowestoft Football Club.

On entry, you are welcomed into a large, open-plan salon area with space for 5 to 6 workstations, making it ideal for a hairdresser, beauty business, or similar venture. To the rear, there is a separate room currently used as a hair-washing station, which also includes a self-contained tanning area.

Beyond this, a small kitchen and toilet provide essential staff facilities. Additionally, a separate side room offers further flexibility, with capacity for an additional 2 to 3 stations or the potential to be used for a different business function.

While the space has been successfully operated as a salon, it does not need to remain in this use. The layout and location make it suitable for a variety of business purposes, including retail, office space, wellness treatments, or other service-based industries.

The surrounding residential area ensures a strong and reliable customer base, while the constant foot traffic from nearby amenities enhances its business potential.

The freehold is available to purchase, with an asking price of £150,000.


