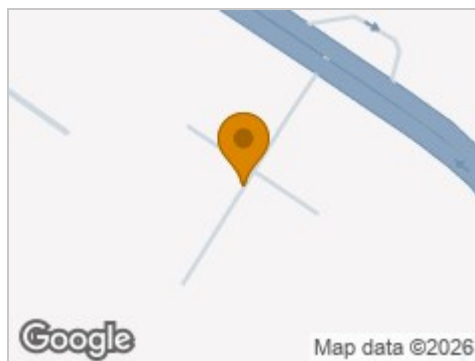

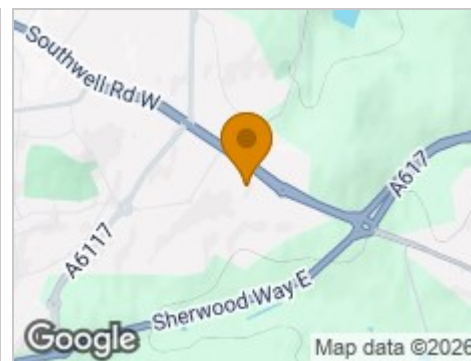
Road Map
