





Location

The site is situated on Silverdale Road (B5044) which runs from Newcastle to Silverdale. Keele University is 1.7 miles away, M6 North (J16) 8 miles away, M6 South (J15) 4 miles away.

The VOA website advises the rateable value for 2025/26 is £2,850 increasing to £3,900 from 1st April 2026. The standard non-domestic business rates multiplier is 55.5p. The small business multiplier is 49.9p up to a rateable value of £50,999. Small Business may benefit for up to 100% on premises with a rateable value of up to £12,000 and a tapered relief for rateable values between £12,000 and £15,000.

Bjb recommends interested parties make their own enquiries into the business rate payable any further business rate relief which may be available.

Tenure

Leasehold - on new terms to be agreed for a preferred term of 3 years or more.

Service Charge

The lease will have a provision within the lease for a service charge which will refer specifically to the maintenance and repair of common areas, namely shared yard, landscaping, site fencing and security. The service charge will be calculated based upon the floor area taken being a percentage of the total floor area available at Silverdale Court.

Proof of Identity
