

Description

Unit 5E is a 334 Sq ft ground floor unit set within a substantial building which has been converted to provide a total of 38 commercial units arranged around a central courtyard. Access into the courtyard is off Nursery Road with each unit providing self-contained accommodation suitable for a variety of uses.

Location

Situated along Nursery Road in the Hockley area of Birmingham approximately 1.5 miles from Birmingham City Centre and within close proximity to Hockley Circus and being situated outside of the Clean Air Zone.

The location has excellent access to the national motorway network at J1 of the M5 Motorway some 4 miles to the west and J6 of the M6 located only 5 miles distant via the A38 (M).

Services

Mains Electric is available and is metered via a sub meter. Shared on-site WC facilities are provided within the building.
