Description

An unusual mixed use property consisting of a former takeaway with residential accommodation, yard / carpark to the rear and an industrial unit all on one site. The ground floor comprises takeaway, commercial kitchen, prep room, w.c, lounge and kitchen for the flat, with the first floor having 4 bedrooms and a bathroom. There is a garage attached to the property for a single car, a side garden, rear parking and a yard with an industrial unit (not inspected).

Location

Hilderstone Road is situated in the Meir Heath area of Stoke-on-Trent, within a well-established residential setting. The road provides convenient access to local shops, schools, leisure facilities and everyday amenities, while the surrounding area offers a mixture of established residential properties and local green spaces.

The location benefits from good road connections to Stoke-on-Trent city centre and the wider North Staffordshire area, with the A50 providing access towards Derby and the M1, while the A500 gives convenient connections across Stoke-on-Trent and towards Newcastle-under-Lyme.

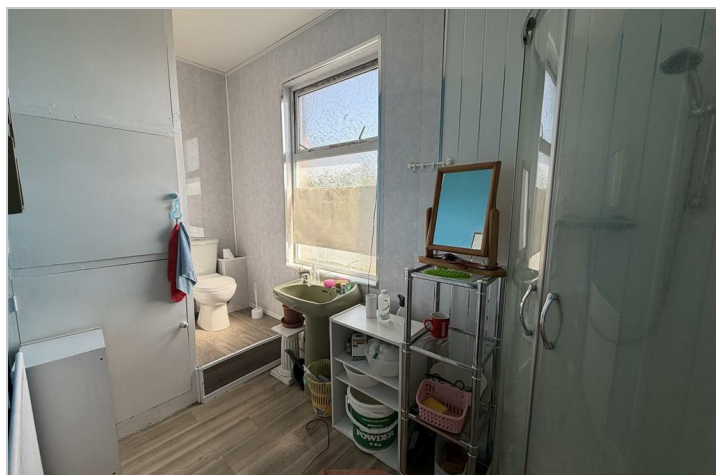

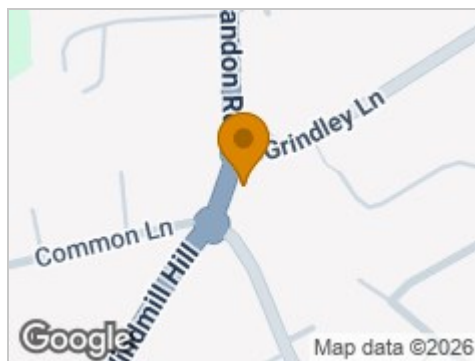

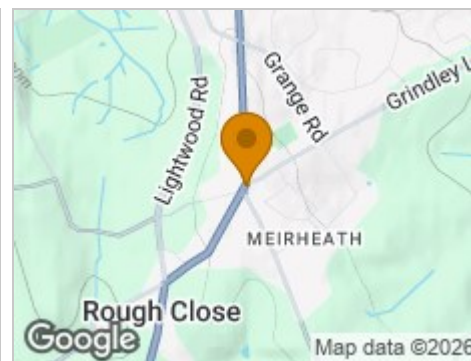
Road Map
