A mixed use part-let investment within the village of Milton, comprising ground floor retail and separate first floor flat. The ground floor has previously been used as a florist but is now currently vacant, the first floor flat is accessed from a separate entrance to the rear and currently let at £400 pcm / £4,800 pa for a 3 year term.

Location

The property is located on Millrise Road in the residential area known as Milton. Milton is a suburb of Stoke-on-Trent and located to the North East of Stoke-on-Trent City Centre (Hanley) and approximately two miles away. There is good access on to the A5009 which provides direct access to the A500 an urban express way through the North Staffordshire conurbation and linking junction 15 and 16 of the M6 Motorway.

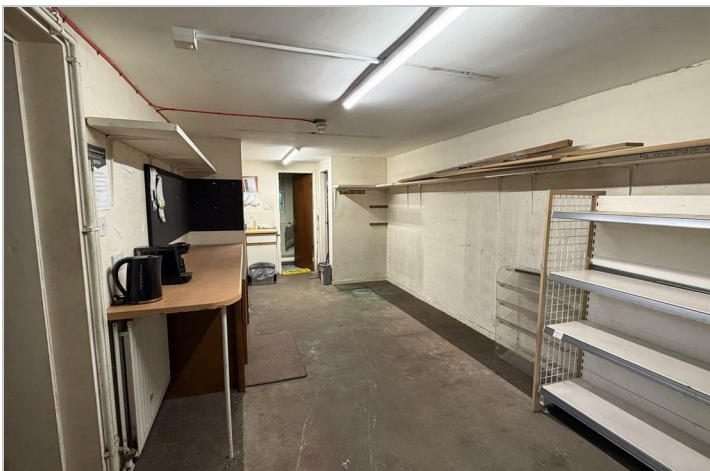

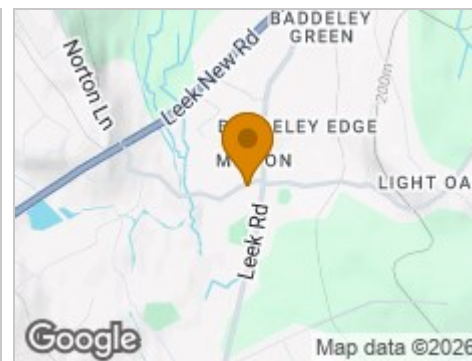
Road Map
