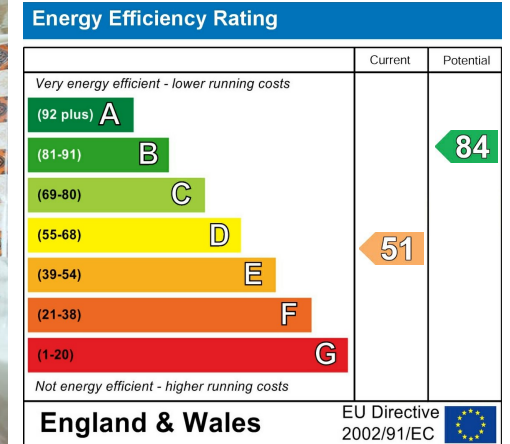

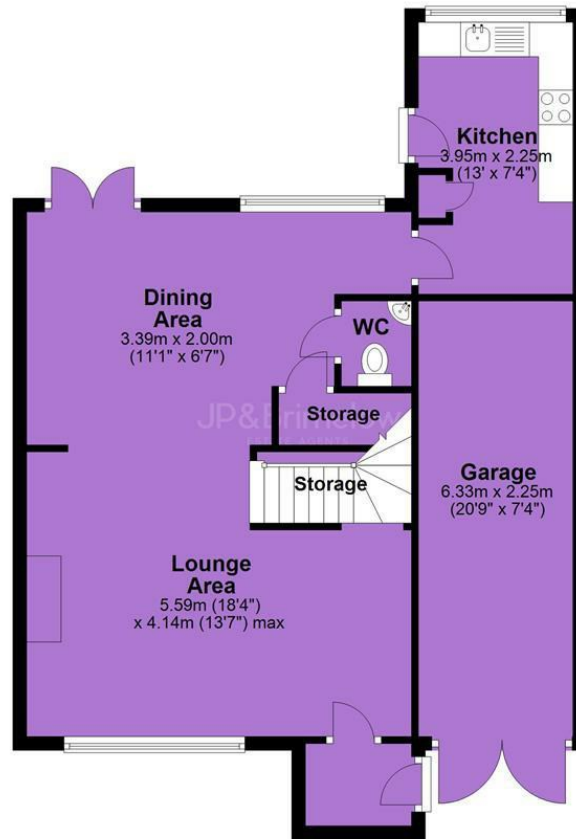


## EPC Chart

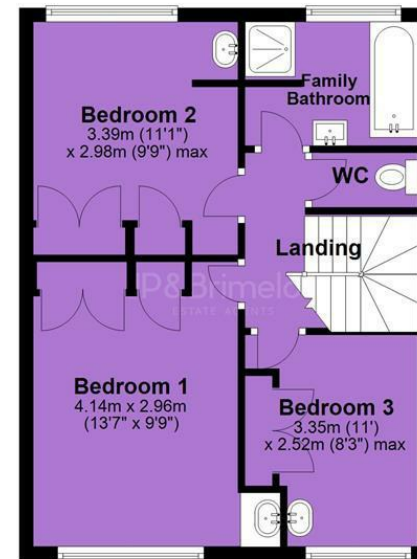
