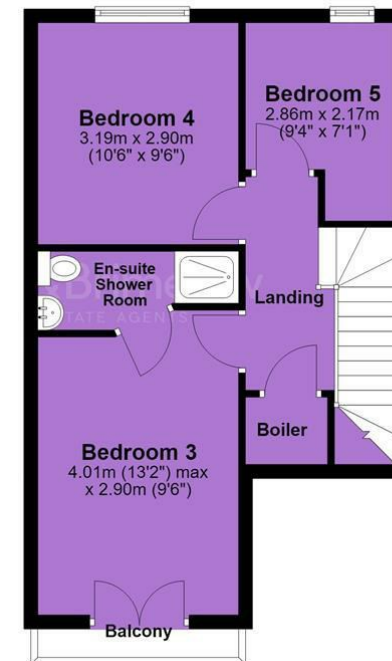
Ground Floor
