Extending over three spacious floors, this superb home has been thoughtfully designed to provide versatile and well-proportioned accommodation throughout. The ground floor comprises a porch leading into a welcoming entrance hall which provides access to a convenient WC and separate utility room. To the front of the property is an elegant living room featuring a distinctive brick-detailed arched bay window, while to the rear is a stunning lounge area that flows effortlessly into the impressive open-plan living and dining space.

The heart of the home is undoubtedly the beautifully appointed kitchen, complete with a central breakfast island, comprehensive fitted units, and bi-folding doors that seamlessly connect the indoor living space with the rear garden, creating an ideal setting for both everyday family life and entertaining.

The first floor reveals four generously sized double bedrooms. One bedroom benefits from built-in wardrobes and a contemporary white three-piece en-suite shower room, while the principal suite allows access to a second-floor dressing room and a stylish three-piece bathroom. A modern family bathroom fitted with a white three-piece suite completes the first floor.
